• There was a Code Revisions presented to the board revising language to section 612 Special Requirements for Pedicabs:

612 Special Requirements for Pedicabs. (Amended 3/21/2017)

- A. Operation:
 - 3. Every Pedicab shall display, on *both* sides exterior of the vehicle, the fare rate in letters at least one inch high and in a color contrasting with that of the vehicle surface.
- After the revision was presented, Chairman Reeves called for a motion to approve the amendment to the Code. A motion was made by Commissioner Rudawsky and seconded by Commissioner Tucci. With no discussion by the board, vote was taken, and the amendment was

approved; Chairman Reeves-yes, Commissioner McNutt-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, Commissioner Osho-yes, Commissioner Fitch-yes, and Commissioner Gilbert-yes.

ADDITIONAL DISCUSSION

- Commissioner Asfaw and Commissioner Osho presented discussion on the aging out of the 2007 on call taxi cabs effective June 1, 2017. They suggested a Code revision be made to allow an on call taxi cab vehicle to age out after ten years in service instead of nine years in service. After discussion by the board, Commissioner Tucci made a motion to modify the agenda to include an additional Code revision on the aging out of on call taxicabs. The motion was seconded by Commissioner Rudawsky, vote was taken and the agenda was modified; Chairman Reeves-yes, Commissioner McNutt-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, Commissioner Osho-yes, Commissioner Fitch-yes, and Commissioner Gilbert-yes.
- With no more discussion on the Code revision added to the modified agenda, a motion was made by Commissioner Osho to amend the Code to allow on call taxi cabs to age out of service after ten years instead of nine. The motion was seconded by Commissioner Asfaw, vote was taken and the amendment was approved; Chairman Reeves-yes, Commissioner McNutt-yes, Commissioner Rudawsky-yes, Commissioner Tucci-yes, Commissioner Asfaw-yes, Commissioner Osho-yes, Commissioner Fitch-yes, and Commissioner Gilbert-yes.
