AGENDA & MINUTES

- The Meeting was called to order by Chairman McNutt at 10:00 AM and the roll was called by Beth Staley: Chairman McNutt-present, Commissioner Satz-present, Commissioner Asfaw-present, Commissioner Osho-present, Commissioner Rudawsky-present, Commissioner Gilbert-Hamacher-present and Commissioner Vianello-present. A quorum being found the meeting began.
- Chairman McNutt made a motion to approve the July 30, 2019 meeting agenda. The motion was seconded by Commissioner Satz. Vote was taken, and the agenda approved; Chairman McNutt-yes, Commissioner Satz-yes, Commissioner Asfaw-yes, Commissioner Rudawsky-yes, Commissioner Osho-yes, Commissioner Gilbert-Hamacher and Commissioner Vianello-yes.
- Following the approval of the agenda, Commissioner McNutt made a motion to adopt the June 25, 2019 meeting minutes. Commissioner Rudawsky requested a typo be corrected. Commissioner Vianello then seconded Chairman McNutt's motion, vote was taken, and the minutes were adopted; Chairman McNutt-yes, Commissioner Satz-yes, Commissioner Asfaw-yes, Commissioner Rudawsky-yes, Commissioner Osho-yes, Commissioner Gilbert-Hamacher and Commissioner Vianello-yes.

August 29th at 10:00a.m. was set as the next regular meeting of the Commission. (approved by consensus, no vote was taken)

NEW BUSINESS

- The Director presented the sale of Show Me Airport Cab to the board. He explained the airport cab company had been having financial issues so the buyer and new stock holders paid all debts owed by old owner, had a contract completed by an attorney and paid all application fees to the Metropolitan Taxi Commission. A motion was then made by Commissioner Satz to approve of the sale of ownership of Show Me Airport Cab, the motion was seconded by Commissioner Asfaw and the sale was approved; Chairman McNutt-yes, Commissioner Satz-yes, Commissioner Asfaw-yes, Commissioner Rudawsky-yes, Commissioner Osho-abstain, Commissioner Gilbert-Hamacher and Commissioner Vianello-yes.
- The Director then presented a Director Rule to try to help resolve the issue of cabs not completing annual inspections on time. The rule was reviewed and discussed by the board, no votes were taken.

- With no public comments and no more on the agenda, Chairman McNutt called for a motion to adjourn the July 30, 2019 meeting.
