Commissioner Osho said he would be abstaining his vote because he did not feel the time was right for a rate increase. Chairman McNutt said this was an option and not all CNN holders would have to increase their rates. Commissioner Vianello asked if this was a way to try to get some of the drivers back and Chairman McNutt said yes, he thinks with the cost of living going up and everything else it is needed for the drivers. Chairman McNutt mover to vote and Commissioner Asfaw second the vote: Commissioner Satz- yes, Commissioner Asfaw-yes, Commissioner Osho-abstain, Commissioner Rudawsky-abstain, Commissioner Vianello-yes, and Chairman McNutt-yes, so the increase was approved.
